1. We acknowledge the course details and fees dated 10.02.2026
2. We will pay the Course fee and other applicable fee as per Option 1 or Option 2
3. Fee Payment Option 1:
 - I. Ground school fee : To be remitted during admission to the course.
 - II. Flying Fee : Full 200hrs flying fee
(with applicable discount for full fee payment)
 - III. Books, Uniform etc : As prescribed, to be remitted during admission to the course
 - IV. Hostel Fee per month : Rs. 16,000/-
4. Fee Payment Option 2:
 - I. Ground school fee : To be remitted during admission to the course.
 - II. Flying Fee,
 - Installment 1 : 50 hrs fee payment at the time of admission
 - Installment 2 : 50 hrs fee payment within one month of commencement of ground classes
 - Installment 3 : 50 hrs fee payment after 6 months from commencement of

classes

Installment 4 : 50 hrs fee payment after 9 months from commencement of classes

III. Books, Uniform etc., : To be remitted during admission to the course

5. From first flying fee payment made, fee paid towards 10 hrs of flying shall be kept as reserve. The same shall be adjusted towards last 10hrs of flying of CPL completion. Student shall be responsible to ensure that 10hrs flying fee reserve is maintained till completion of 190hrs

6. Cut off dates for Hostel fee:

- I. Hostel fee @ Rs. 16,000/- Per month : 01st day of current calendar month
- II. Late Hostel fee with fine @ Rs.1000/-per month: From 06th day of current calendar month

If Hostel Fee is pending for more than two months, student shall be liable for suspension from hostel.

If Hostel Fee is pending for more than three months, student shall be liable for suspension from course also.

- 7. Other than prescribed flying fee break ups, we will not seek any further time or concession for the payment of course fee / hostel fee / additional fee in installments and will remit the fee as prescribed.
- 8. Late payment fee, with fine would be applicable beyond specified time given to each batch.
- 9. Student/ Guardian are responsible to pay penalties if the fees are not paid on time.
- 10. We acknowledge that the present flying fee charges are as per current market fuel prices, and any hike in the price of fuel or other inputs costs will constitute additional charges towards course fee.
- 11. We will strictly adhere to maintain minimum attendance as required during the course
- 12. The student shall be responsible for reconciling his / her log books on weekly basis as per actual hrs flown.
- 13. It is the student responsibility to find out all dead line dates for all course procedural / examination requirements as needed from time for completion of his course.
- 14. We shall not hold the organization Flytech Aviation Academy responsible for any accident/incidents which result in injury / death to the candidate. We are aware of the flight training risks & accept the same.

15. In case of any misbehavior or any other indiscipline activity from the student, the Academy reserves the right to take necessary action as deemed fit, including permanent suspension from Academy.
16. We undertake to strictly take care of safety of all Academy property handled by him/her and reimburse to Academy any costs & additional charges towards damages due to negligence. The Management decision will be final in all such matters
17. Students will not be permitted for Hostel withdrawal until Course completion. In case he/she seeks Hostel withdrawal in between the course, he/ she shall pay the full prescribed Hostel fee till the end of the course
18. Hostel Caution Deposit will become non refundable deposit in case of in between drop from the hostel and course.
19. In case the candidate discontinues his/her studies at Flytech Aviation Academy, for whatever reasons thereof i.e Withdrawal/suspension/rustication etc, we will not ask for any refund or transfer of payments
